In this context, this Lighthouse Program Privacy Notice ("**Privacy Notice**") provides detailed information regarding the processing of personal data of the data subjects requesting to participate in the Lighthouse Program.

### Collection Method, Processing Purpose and Legal Basis of Processing of Your Personal Data

### Your Rights

In accordance with the applicable legislation, you may have the right to:

- Learn whether your personal data is being processed or not,
- Request information regarding your personal data if it is being processed,
- Learn the purpose of processing of your personal data and whether they are used in accordance with such purpose,
- Learn the third parties to whom personal data are transferred domestically or abroad,
- Request correction of your personal data if it is incomplete or processed incorrectly,
- Request deletion or destruction of your personal data within in accordance with the applicable legislation,
- Request notification of the third parties to whom your personal data are transferred to regarding the correction of your incomplete or incorrectly processed personal data,
- Request notification of the third parties to whom your personal data are transferred to regarding the deletion or destruction of your personal data,



- Object to the negative decision regarding yourself, that would occur due to the data processing to be conducted solely automated means,
- Claim compensation for the damage arising from the unlawful processing of your personal data.
